Tata Power to develop 50MW at Dholera Solar Park in Gujarat

Xiaomi patents foldable phone with 5 pop-up cameras

Beijing, Nov
Chinese smartphone manufacturer Xiaomi has patented a foldable smartphone with five pop-up camera setup. According to the patent, Xiaomi's foldable phone has an outward-folding screen and depending on how a user holds it, the five cameras can either be rear cameras or front-facing cameras, news portal GizmoChina reported on Sunday.

The sketches of the device suggest that it will have a really thin bezels and no display notch. The patent seems to have been submitted on August 20 and was approved and published last week.

The patent also shows the pop-up sit on the left side of the foldable phone when unfolded.

Last week Xiaomi launched its latest smartphone Mi CC9 Pro with five rear cameras, including a 108MP primary sensor in China. The phone features a 6.47-inch curved full-HD+ (1080x2340 pixels) OLED display. The device is powered by Qualcomm's Snapdragon 730G processor paired with up to 8GB of RAM and 256GB of internal storage.

Galaxy S11 tipped to come in 3 sizes, 5 variants

Seoul, Nov
An American tech blogger has claimed that the upcoming Samsung Galaxy S11 smartphone will be available in three screen sizes - 6.4 or 6.2-inch being the smallest, mid-sized with 6.4-inch and 6.7-inch being the largest one.

Even Blass also claimed that there would be five variants in total that all sport curved-edge displays. On the part of connectivity, the two small variants of the smartphone will come in 5G and LTE, whereas the largest 6.7-inch variant will be 5G only, GSM Arena reported on Sunday.

Earlier, famed leaker Ice Universe had claimed that the Galaxy S11 would not use the 108MP ISOCELL Bright HMX sensor that it launched earlier this year, but would instead utilise an upgraded second-gen sensor. Opting for a second-gen version of Samsung's 108MP lens would also make sense, since the original version has on a Xiaomi handset first, so it won't be a totally new thing by the time the Samsung Galaxy S11 launches. As per a recent report, Galaxy S11 would arrive in the third week of February 2020 and the launch event is said to take place in San Francisco.

In reverse gear: Festivals fail to boost auto sales
